

Information pursuant to Article 13 of EU Regulation 2016/679

With this information, details are provided regarding the processing of personal data for those interested in participating in the expression of interest for the use of the Research Vessel (R/V) Gaia Blu for activities in the Mediterranean Sea between June and December 2024. Data will be processed in compliance with the principles of fairness, lawfulness, transparency, and confidentiality, as well as with European and national provisions on personal data protection under EU Regulation 679/2016 and Legislative Decree of June 30, 2003, no. 196, as amended by Legislative Decree of August 10, 2018, no. 101 (known as the Privacy Code).

DATA CONTROLLER

PURPOSE AND BASIS OF PROCESSING

Interested parties are informed that the processing of the personal data provided is aimed at carrying out activities related to the procedure (call for proposals 2024) for the use of the R/V Gaia Blu for activities in the Mediterranean Sea in 2025.

The data provided is mandatory to achieve the aforementioned purposes; failure to provide, partial or incorrect provision of data will result in the impossibility to participate and proceed with the procedure. The relevant legal provisions are contained in Legislative Decree 30.03.2001 no. 165, containing "General rules on the organization of labor in public administrations" and subsequent amendments.

TYPES OF DATA PROCESSED AND METHODS OF PROCESSING

The categories of data processed are personal data, specifically identification, personal, and contact details contained in the application form. The Controller does not adopt any automated decision-making process, including profiling as referred to in Article 22, paragraphs 1 and 4 of EU Regulation no. 679/2016.

DATA RECIPIENTS

The processed data will not be disseminated, except in cases provided for by applicable regulatory provisions, with particular regard to the rules on transparency and publicity, Legislative Decree 33/2013 and subsequent amendments, and may be communicated to third parties or made accessible exclusively for the comparative procedure under the conditions provided for by law. Such personal data, once acquired from the interested party solely for the achievement of the indicated purposes, may be processed by employees of the CNR authorized to process personal data. The processed data will not be transferred to countries or international organizations.



DATA RETENTION PERIOD

Personal data relating to the personnel units will be retained for the time necessary to complete the procedure in question.

RIGHTS OF THE DATA SUBJECTS

Regulation (EU) 2016/679 grants the subject the following rights: a) right of access (Article 15 of Regulation (EU) 2016/679); b) right to rectification (Article 16 of Regulation (EU) 2016/679); c) right to erasure (Article 17 of Regulation (EU) 2016/679); d) right to restriction of processing (Article 18 of Regulation (EU) 2016/679); e) right to data portability (Article 20 of Regulation (EU) 2016/679); f) right to object (Article 21 of Regulation (EU) 2016/679). Concerning the processing of data, the data subject may contact the Acting Manager of the Research Infrastructures Office, the contact point of the Data Controller, to exercise their rights, or alternatively, the Data Protection Officer at the above contacts.

RIGHT TO LODGE A COMPLAINT

Data subjects, in case they believe their personal data have been processed in violation of the provisions of EU Regulation 679/2016, have the right to lodge a complaint with the Data Protection Authority, as provided for by Article 77 of EU Regulation 679/2016, or to take appropriate judicial steps pursuant to Article 79 of EU Regulation 679/2016.
